## PREPARATION OF MANUSCRIPTS

- (1) Manuscripts should be typed on A4 paper, double-spaced with generous margins on all sides of the paper. Two copies of the manuscript should be furnished and, wherever possible, accompanied by a diskette of the manuscript.
- (2) Footnotes should be numbered consecutively from 1 to 99 and typed double-spaced on separate sheets at the end.
- (3) Final responsibility for the accuracy of all citations and quotations rests with the contributors.
- (4) Paragraphs start flush left after headings but otherwise are indented.
- (5) Quotations of more than 30 words should be indented without marks. Shorter quotations within the text should be enclosed by single inverted commas.
- (6) The following should be in italics:

  - (ii) Latin and other foreign words
  - (iii) Abbreviations - *eg, ie, ibid, cf.*
  - (iv) Titles of books and law journals/periodicals
